## Covid-19 / Coronavirus Liability Waiver and Assumption of the Risk

I (or my child) acknowledge the contagious nature of the Coronavirus/Covid-19 and that the CDC and many other public health authorities still recommend practicing social distancing and various other means of avoiding infection and preventing spread of Covid-19.

I (or my child) further acknowledge that Whole Armor Martial Arts, Inc. has attempted to comply with and is continuing to attempt to comply with the recommendations from state and federal agencies and has put in place preventative measures to reduce the spread of the Coronavirus/Covid-19.

I (or my child) further acknowledge that Whole Armor Martial Arts, Inc. can not guarantee that I will not become infected with the Coronavirus/Covid-19 while it is still active in society. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/Covid-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, school staff, and other students and their families who may be present at classes, and even the facility in which classes are held. I voluntarily seek services provided by Whole Armor Martial Arts, Inc. and acknowledge that I am increasing my risk of exposure to the Coronavirus/Covid-19. I acknowledge that such exposure or infection may result in personal injury, illness, permanent disability, and death to anyone exposed to or infected by Covid-19.

I (or my child) acknowledge that I must comply with all set procedures to reduce the spread while attending my class.

I (or my child) agree to not attend class if any of the following are true:

- I (or my child) am experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, sore throat, or new loss of taste or smell.
- I (or my child) am aware of having been exposed to someone with a suspected and/or confirmed case of the Coronavirus/Covid-19.
- I (or my child) have been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.

I hereby release and agree to hold Whole Armor Martial Arts, Inc. harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the school, or that may otherwise arise in any way in connection with any services received from Whole Armor Martial Arts, Inc. I understand that this release discharges Whole Armor Martial Arts, Inc. from any liability or claim that I, my heirs, or any personal representatives may have against the academy with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from Whole Armor Martial Arts, Inc. This liability waiver and release extends to the school together with all owners and instructors, and also includes Bethel Lutheran Church, and it's staff.
